The 2020 Sustainability Report, which is prepared on a voluntary basis by reporting a selection of international standards from the "GRI Sustainability Reporting Standards" based on the "Referenced" reporting option, represents a further important step in the company's Corporate Social Responsibility path. This supports our desire to continue to develop the business in a sustainable way, in a way that is both transparent and that takes the interests of stakeholders into account.

The pillars of Doxee's sustainable development are based on accompanying and supporting the Digital Transformation of businesses and Public Administrations, reducing the Digital Divide of citizens by improving social welfare, optimizing document management and distribution processes, and dematerializing billing and storage processes.

To this end, and as an enabling factor, the management policies of Doxee's business processes are of great importance. The attention to **internal environmental issues** and the simultaneous goal of improving the welfare of the community is also made concrete by the recent adoption of the ISO 14001 system, which ensures the management and control of environmental aspects related to Doxee products and services, with particular attention to energy consumption.
